Remember BGS in your will



Many alumni have bequeathed some of their estate to the School in their will.

Sometimes they stipulate that the legacy is to be given to improve the school buildings, classrooms or sports equipment.

The School usually then remembers the legacy by way of a special plaque. Others may leave a legacy to the bursary fund or simply leave how to assign the legacy to the discretion of the Governors.

It is usually relatively inexpensive to make a will or to amend it by adding a codicil to arrange the gift of a specific sum of money. Please remember that if you are leaving a legacy to quote the School's registered charity number, 529113, registered in England and Wales.
